In our opinion and to the best of our information and according to the examinations carried out by us and explanations furnished to us by the Company, its officers and agents, we certify that:

- A. the Annual Return states the facts as at the close of the aforesaid financial year correctly and adequately.
- B. during the aforesaid financial year the Company has complied with provisions of the Act & Rules made there under in respect of:
 1. Its status under the Act.

 3. 6. The Company has not given any advances/loans to its directors and/or persons or firms or companies referred in section 185 of the Act.
7. All the contracts/arrangements with related parties as specified in section 188 of the Act are at arms' length and approved omnibus by the Audit Committee and which are repetitive in nature and also by the board and by taking MBP-1 on record at the meeting of Board of Directors.
8. The Company has not issued or allotted or bought back any securities during the period under scrutiny. Transfer or transmission of securities are carried out by the registrar and share transfer agent of the Company in due compliance with the Act.
9. There is no need of keeping in abeyance the rights to dividend, rights shares and bonus shares pending registration of transfer of shares.
10. The Company has not declared dividend during the year under review. The Company is not required to transfer any amount to the Investor Education and Protection Fund in accordance with section 125 of the Act during the year under review.

13. Appointment of auditors was made as per the provisions of section 139 of the Act.
14. There was no instance occurred during the year which require approvals to be taken from the Central Government, Tribunal, Regional Director, Registrar, Court or such other authorities under the various provisions of the Act.
15. The Company has not accepted deposits falling under the provision of Section 73 of the companies Act, 2013 during the year under review.
16. Borrowings from the banks, Directors and other are within the limit prescribed by the Company and there was no instance occurred during the year requiring creation/ modification of charges in that respect.
17. The Company has not provided any loan or given guarantees to other bodies corporate or person falling under the provision of section 186 of the Companies Act, 2013 and investments made are within the limit under the provisions of section 186 of the Act.



18. The Company has not altered Memorandum of Association and Articles of Association of the Company during the period under review.
